- **Enhanced search capabilities within Payment History...** you can search by Date, Type, Amount, Tax Form, and EFT Acknowledgement Number
- **Increased Accessibility for the disabled**
- **New Links to states with electronic tax payment services**
- **Use the Express Enrollment feature when Editing Financial Institution information**
  - You can bypass the financial institution verification step and save up to two weeks time in receiving a new PIN

- **Enhanced and expanded Glossary and Help & Information sections**

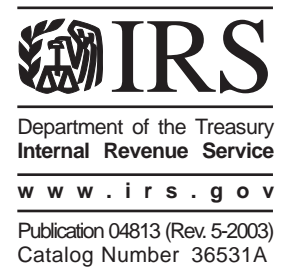

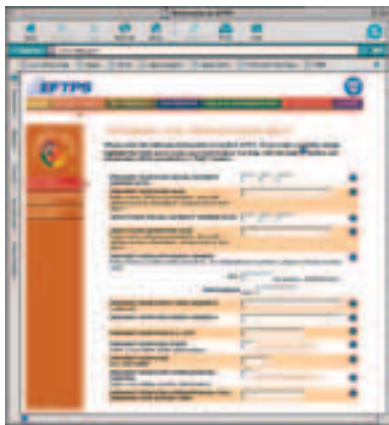

## ENROLL NOW

Enrollment online is easy.

- **Go to [www.eftps.gov](http://www.eftps.gov)**
- **Have your Taxpayer Identification Number** (Social Security Number, SSN or Employer Identification Number, EIN) and your bank account information handy
- **Select your state** on the Welcome page
- **On the Home Page**, under the Enrollment tab, select Business or Individual (You might want to bookmark the Home Page for future reference)
- **Then proceed to enter the information** in the step-by-step screens that follow
- **When you're finished**, print out a copy of your "Congratulations" page that contains your Enrollment Trace number

Within 10-15 days, you'll receive a Confirmation package by mail, as well as a Personal Identification Number (PIN) separately. Within the Confirmation package, you'll receive instructions on how to obtain your Internet Password. You will be given an 800-number to call that will activate your online account and provide you with a temporary password.

## MAKE A PAYMENT IN MINUTES

You can make your payments in a matter of minutes 24 hours a day, 7 days a week. Once you know your payment amount, go online or call the EFTPS 800-number at least one calendar day before the due date, and schedule your payments to be made automatically on the date you want.

- **Go to [www.eftps.gov](http://www.eftps.gov)**
- **Select your state** on the Welcome page
- **On the Home Page**, under the Payment tab, select Make a Payment
- **Logon** by entering your TIN, PIN and Internet Password
- **Enter the payment information** in the step-by-step screens that follow
- When you're finished, **print out a copy of the "Payment Confirmation" page**. This contains your EFT Acknowledgement Number that acts as a receipt for your payment.

The money will move from your bank account to Treasury's account on the date(s) you indicate. IRS only receives the tax payment information to update your tax records. IRS does not have access to your financial institution account information.

## CHECK YOUR PAYMENT STATUS OR REVIEW YOUR PAYMENT HISTORY

With EFTPS-OnLine, you can logon and check all EFTPS payments you have made in the last 120 days\*. Your payment history contains the type of payment, when it was made, how it was made, how much, when it was received, and when it settled. All this information is available to you online 24 hours a day, 7 days a week.

If you prefer to call about your payment history, you can call EFTPS Customer Service.

\* Beginning in June 2003, EFTPS will begin storing 16 months of your payment history.

## SCHEDULE YOUR PAYMENTS IN ADVANCE

If you know you will be out of town or busy when a tax payment is due, EFTPS lets you schedule your tax payment in advance—up to 365 days in advance for personal tax payments and up to 120 days in advance for business tax payments. You can make payments weekly, monthly, even daily if you want.

EFTPS is especially useful for scheduling your 1040ES quarterly estimated payments for the whole year. Or you can make your quarterly payments one at a time. It's up to you.

And if you need to change any scheduled payment, it's easy. You can make changes up to two business days in advance of the scheduled payment date online or by calling Customer Service.

### What could be easier?

Don't worry about missing a payment because you're out of town or on vacation. And don't worry about remembering to make your payments on the right dates. EFTPS takes the worry out of paying your federal taxes on time.
